**Announcement regarding the acquisition of  
Eastern Green Marketing Pte. Ltd. and Alamanda Singapore Pte. Ltd.**

Kamei Corporation (Sendai, Miyagi, President & CEO: Fumiyuki Kamei, “Kamei”) announced that Kamei Singapore Pte. Ltd. (Singapore, ”KSP”) , a subsidiary of Kamei, has acquired 100% shares of Eastern Green Marketing Pte. Ltd. and Alamanda Singapore Pte. Ltd. (Singapore, collectively ”EGG”) on August 31 2021.

1. Purpose of the acquisition

Kamei currently operates in 8 business segments: energy, food, construction, automotive, international trade, pet, pharmacy, and others.

Meanwhile, EGG is one of the leading fruits and vegetables importer and wholesaler in Singapore.

One of our priority strategies is expansion of overseas business through our domestic trading subsidiaries and overseas subsidiaries.

By welcoming EGG into Kamei group through this acquisition, we expect that we will be able to expand and strengthen our group’s food business and food business in Singapore, and build a strong business foundation in the rapidly growing Southeast Asia region.
